

ACIS Fitness Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

Sweepstakes Dates: The ACIS Fitness Sweepstakes ("Sweepstakes") begins 12:01 a.m. Eastern Time on 03/4/2013 and ends at 11:59 p.m. Eastern Time on 04/15/2013 (the "Promotion Period").

Who is Eligible: To enter, you must be a legal resident of the 50 United States or District of Columbia, 18 and older and have valid proof of U.S. citizenship. Limit: One (1) Entry per person. In the event more than one (1) entry is received from any one person, the first entry processed will be considered the only valid entry received for that Entry Period. Entrants must complete all required information on the entry form to be eligible. No one may enter another individual's name into the Sweepstakes.
